**AUDITOR'S REPORT
ON FORM 922, CANDIDATE'S FINANCIAL STATEMENTS
AND SUPPORTING SCHEDULES**

To Mr. John Shead, Official Agent for Jack Jonasson.

We have audited Form 922, Candidate's Financial Statements and Supporting Schedules, prepared in accordance with the accounting requirements of The Elections Finances Act of Manitoba and the Accounting Guide – Accounting For Purposes of The Elections Finances Act issued by the Chief Electoral Officer, for the candidacy of Jack Jonasson for the candidacy period from January 7, 2003 to August 4, 2003 relating to the election held on June 3, 2003 in the Electoral Division of Selkirk. The financial statements are the responsibility of the Official Agent and the Candidate. Our responsibility is to express an opinion on the financial statements based on our audit.

We conducted our audit in accordance with generally accepted auditing standards. Those standards require that we plan and perform an audit to obtain reasonable assurance whether the financial statements are free of material misstatement. An audit includes examining on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by the Official Agent and Candidate, as well as evaluating the overall financial statement presentation.

In our opinion, Form 922, Candidate's Financial Statements and Supporting Schedules for Jack Jonasson are presented fairly, in all material respects, in accordance with the accounting requirements of *The Elections Finances Act of Manitoba* and Accounting Guide – Accounting For Purposes of The Elections Finances Act issued by the Chief Electoral Officer.

Further, we report that the total income and transfers of \$10,565.00, and the total expenses and transfers of \$17,676.34 for the candidacy period are the same as the related totals in Form 922, Candidate's Financial Statements and Supporting Schedules.
