I have audited Form 922, Candidate's Financial Statements and Supporting Schedules, prepared in accordance with the accounting requirements of *The Elections Finances Act* of Manitoba and *Accounting Guide – Accounting For Purposes of The Elections Finances Act* issued by the Chief Electoral Officer, for the candidacy of Janelle Mailhot, for the candidacy period from April 27, 2007 to July 23, 2007, relating to the election held on May 22, 2007, in the Electoral Division of Ste. 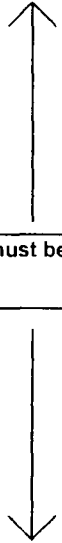
