INDEPENDENT AUDITORS' REPORT

We have audited the accompanying Form 947, Leadership Contestant's Financial Statements and Supporting Schedules, which comprises the Statement of Assets, Liabilities and Surplus (Deficit) as at May 8, 2015, and the Statement of Income and Expenses of the Steve Ashton Leadership Campaign, for the leadership contest period of December 15, 2014 to May 8, 2015 for the leadership vote of the Manitoba New Democratic Party held on March 8, 2015 and a note describing the basis of accounting. (the statements) The statements have been prepared by the Official Agent based on the financial reporting provisions of the Elections Finances Act of Manitoba.

Official Agent's Responsibility for the Statements

The Official Agent is responsible for the preparation of the statements in accordance with the financial reporting provisions of The Elections Finances Act of Manitoba, and for such internal control as the Official Agent determines is necessary to enable the preparation of the statements that are free from material misstatement, whether due to fraud or error.

Auditors' Responsibility

Our responsibility is to express an opinion on the statements based on our audit. We conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by the Official Agent, as well as evaluating the overall presentation of the statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Basis of Qualified Opinion

Due to the nature and types of transactions inherent to any leadership campaign, the completeness of contribution income and fundraising is not susceptible of satisfactory audit verification. Accordingly, our testing of contribution income and fundraising was limited to the amounts recorded in the leadership contestant's records and we were not able to determine whether any adjustments might be necessary to assets, liabilities, income, expenses and the period surplus/deficit.

In our opinion, except for the effects of the matters described in the Basis of Qualified Opinion paragraph, Form 947 Leadership Contestant's Financial Statements and Supporting Schedules of the Steve Ashton Leadership Campaign, for the leadership contest period of December 15, 2014 to May 8, 2015 for the leadership vote of the Manitoba New Democratic Party held on March 8, 2015, are prepared, in all material respects, in accordance with the financial reporting provisions of The Elections Finances Act of Manitoba.

Basis of Accounting

Without modifying our opinion, we draw attention to Note 1 of the statements, which describes the basis of accounting. The statements are prepared to comply with the financial reporting provisions of The Elections Finances Act as issued by Elections Manitoba. The statements are filed with Elections Manitoba in accordance with The Elections Finances Act of Manitoba. As a result, the statements may not be suitable for another purpose.

Other Matter

Our previous auditors' report dated May 29, 2015 has been withdrawn. We draw attention to Note 2 of the statements which discusses amendments made to the statements by the Official Agent on June 23, 2015. Our procedures on subsequent events are restricted solely to the amendment of the financial statements as described in Note 2.

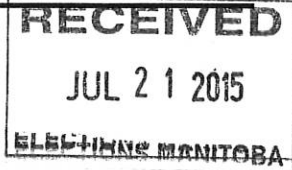
